2021 REAL ESTATE AND PER CAPITA TAX INFORMATION

As of today I am happy to announce that there will be hours at the township building for 2021. Should the township building be closed, payments will be collected outside at the picnic pavilion. The hours will be during the last two weeks of discount:

• Sept 24, 25, 28 from 9-10 AM and Sept 23, 27, 29 from 6-7 PM

These dates and times will be listed on your tax bills.

You may pay by mail. Mail in payments must be received or postmarked by the due date. If a receipt is needed, please include a self-addressed stamped envelope or this year you can provide an email address and a receipt will be emailed to you.

Payments can also be made by calling for an appointment. 814-786-7340

Payments should be made out as shown here: "Wolf Creek Township Tax Collector."

You will also note on the per capita bill, Mercer County no longer has a per capita tax. Wolf Creek Twp and Grove City Area School District per capita tax remains the same as in previous years.

As a reminder:

1. When demolishing a structure the county needs to be notified so they can update the real estate taxes. Real estate taxes will be billed on the structure until the county is notified.

- 2. Mobile home removal permits can be obtained from the tax collector.
- 3. If you are moving out of the township or know of someone moving into the township, please contact the tax collector so the per capita records can be updated.

Township News

Again this year, Seal Coating will take place on various Township Roads, through the Mercer County Joint Seal Coat Program. The Supervisors have budgeted \$171,000 for the maintenance and repairs of Township Roads, including seal coating, paving projects, materials, such as stone, anti-skid and salt for the roads during the winter months, and also funding for routine maintenance. Also included in the 2021 annual budget are funds allocated for the renewed contract with the Pine Township Engine Company.

The Township also has an application submitted to the Department of Community and Economic Development to receive \$85,933.42 through the American Rescue Plan, which is a \$1.9 trillion Federal Coronavirus relief package. Half of these funds will be distributed this year and the remaining funds will be distributed in 2022. There are guidelines from the Department of Treasury on how these funds can be spent. Roads and Bridges are excluded from the allowable uses. These funds will also help with replenishing revenue shortfalls due to the pandemic.

For Emergency Management purposes, the Township would like to develop and maintain a list of any special needs individuals. This could include anyone who may need assistance in: 1) Arranging for or getting transportation for the Covid-19 vaccination, 2) During times of severe weather, such as heavy snow or flooding, 3) During times of electrical outage, 4) Any other emergency related circumstance. If you or someone you know meets this need, please provide the Township all contact information, including name, address, phone number, and nature of the special need such as handicapped, living alone, no transportation, etc.

The Keep Pennsylvania Beautiful Program has extended their gratitude to Wolf Creek Township and Amy Howard for their support in adopting this program. A sign was placed on Elliott Road recognizing both the Township and Amy for their contribution in collecting litter and their efforts in keeping our Township clean and beautiful.
