

WOLF CREEK TOWNSHIP INFORMATIONAL LETTER

Greeting Residents of Wolf Creek Township:

Wolf Creek Township's Annual Clean Up Day will be held on Saturday, August 19, 2023 between the hours of 8:00 A.M. and 12:00 noon, at the Township Garage. This year, we will be collecting General Rubbish only. The following items are excluded:

- 1. NO Paint Cans unless sealed and dry.
- 2. NO Refrigeration Units unless tagged with an Official Certification Sticker "Freon Removed" from a Registered Technician.
- 3. NO Electronics this year.
- 4. NO Tires this year.

If you have **Scrap Metal** you wish to donate, we will have a Township Truck parked at the Garage for collection.

TOWNSHIP NEWS

Seal Coating will take place on various Township Roads through the Mercer County Joint Seal Coat Program. The 2023 Budget includes \$143,000 allocated in the Liquid Fuels Account for road maintenance, including seal coating, routine maintenance, and the purchase of road materials to maintain the quality and safety of the roads. From the General Fund, the Pine Township Engine Company receives \$8,500 for fire protection, plus the Township pays a portion of the fireman's worker's compensation. An annual donation is made to the Grove City Community Library and the Grove City Historical Society. Also included in the 2023 Budget, funds have been allocated for paving approximately .7 of Centertown Road, using the American Rescue Plan funds, distributed by the U.S. Treasury, during the pandemic.

TAX ASSESSMENT INFORMATION

The Mercer County Commissioners advised the Tax Collectors, at the spring meeting, the County is performing a complete re-assessment, which will entail a Mercer County Assessor physically coming to your property. If you are not home, they will leave a yellow door tag and you will need to call them back with the information requested. If you do not comply, they will do it aerially along with google, which could make your assessment not accurate. As of now, this is all the information the Township and the Tax Collector have received. For more details contact the assessment office at the Mercer County Courthouse. This is different than the pictometry that was completed in 2020.

2023 REAL ESTATE AND PER CAPITAL TAX INFORMATION

I will have hours at the township building during the last two weeks of discount: September 22, 23 and 25 from 9-10 AM and September 21, 26 and 27 from 6-7 PM

These dates and times will be listed on your tax bill.

You may also pay your bill by mail to Amanda McGhee, Wolf Creek Township Tax Collector, 218 Elliott Road Grove City PA 16127. All mailed payments MUST have a telephone number on them in case there is an issue that needs resolved so as the Tax Collector can reach you in a timely manner. If no telephone number is on the check, then it will be mailed back to the Tax Payer if issues arise; which may mean you no longer fall in discount/face or penalty period. Mail in payments must be received or postmarked by the due date applicable (discount/face/penalty). If a receipt is needed, please include a self-addressed stamped envelope or you can provide an email address and a receipt can be sent via email (the email address must be legible). You can also schedule an appointment for in person drop off at my home at 724-866- 2873. No checks will be accepted after December 15th.

When demolishing a structure, the county needs to be notified so they can update the real estate taxes. Real estate taxes will be billed on the structure until the county is notified.
Mobile home removal permits can be obtained from the Tax Collector
